BISHOP LAVALLEY TO MEET WITH COUNCIL OF DEACONS

Bishop Terry LaValley will meet with the Council of Deacons on Saturday, December 9, 2017 in Brzana Hall of St. Mary's Cathedral, Ogdensburg. The meeting begins at 10:30 am.

Bishop authorized the formation of the Council in May 2015 at the Diocesan Deacon Assembly. The inaugural meeting of the elected and ex-officio members was held in October 2015.

HOW DO THE COUNCIL OF DEACONS AND ST. LAWRENCE SOCIETY FIT TOGETHER?

The Council of Deacons and the St. Lawrence Society are not competitors. The Society was formed in the 1980's to address some post-ordination concerns among the few deacons who had then completed formation and been assigned to work in parishes. The major concerns were the lack of spiritual, educational and social opportunities for deacons and their spouses. Over the ensuing years the Society has evolved but the original stated purpose remained.

In 2013 during a meeting with the leadership of the Society, Bishop Terry LaValley proposed an Assembly of all deacons in the Diocese. It was during that Assembly the following May that Bishop suggested the formation of Council to advise him as the existing Council of Priests and Council of Religious do.

A committee was charged with drafting a Constitution and By-laws. The final document, approved May 6, 2015, established a purpose for the Council:


1. To provide a forum for the full and free discussion of all issues pertaining to the pastoral ministry of all deacons of the Diocese of Ogdensburg.
2. To aid the Diocesan Bishop and the priests in the pastoral care of the faithful of the Diocese by proposing ways and means for more effective pastoral ministry.
3. To assist the Bishop in planning, coordinating and evaluating the pre-ordination and post-ordination educational and spiritual formation of the deacons.
4. To assist the Bishop in addressing and supporting the unique needs of the deacon family.

The Society has now embraced item three above and, consistent with its own Constitution, is working to coordinate post-ordination educational and spiritual formation of deacons, wives and widows. Deacon John Drollette will chair the education committee. Mrs. Mary Lou Kilian will chair the committee charged with developing a program of prayer and spiritual growth.
